DATABASE POLICY

Introduction

The Horse Riding Clubs Association of Victoria Inc. (**HRC AV**) developed a database (**Database**) of affiliated horse riding clubs and members for use by HRC AV, HRC AV Level Assessors, members and HRC AV clubs for a range of agreed purposes.

HRC AV's Database complies with the HRC AV Privacy Policy and legislative requirements governing the collection, storage, use and disclosure of personal information in the Australian Privacy Principles contained in the *Privacy Act 1988* (Cth). The HRC AV has endeavoured to ensure the development and management of the Database reflects the interests and requirements of HRC AV Clubs and members. This Policy outlines the rights and obligations of all persons and Clubs and organisations to which the Database applies.

Intellectual property

Subject to the specific agreement in place between HRC AV and the third party contracted by HRC AV to develop the Database (**Third Party Contractor**), the Intellectual Property Rights in the computer software used to operate the Database is owned by the Third Party Contractor.

HRC AV Clubs, officials and members acknowledge and agree that HRC AV retains ownership of Intellectual Property Rights in relation to the Database, all data contained within the Database and any associated information which HRC AV or the Third Party Contractor may obtain from HRC AV's use of the Database, including but not limited to member information.

Accordingly it is acknowledged and agreed by all parties that HRC AV in its sole discretion retains the right to:

- (a) use the Database in accordance with the objects of HRC AV and this Policy;
- (b) sub-licence the use of, and access to, the Database to HRC AV Clubs and other affiliated bodies in accordance with this Policy;
- (c) take all necessary steps to protect the rights and value in the Database from infringement by unauthorised persons or organisations; and
- (d) make such upgrades and amendments to the Database as may be required from time to time to maintain the functionality and value of the Database.

For the purpose of this Policy, "Intellectual Property Rights" mean statutory and other proprietary rights in respect of trade marks, patents, copyrights, designs, confidential information, know-how and all other rights with respect to intellectual property.

Privacy

Information contained in the Database will be collected, used and disclosed in accordance with the HRCav Privacy Policy available at www.hrcav.com.au and the *Privacy Act 1988* (Cth).

It is recognised that the compilation of the Database is both reasonable and necessary for, amongst other things, the effective administration of the Association and the promotion of equestrian sports.

Access to Database

Access to the Database will be limited such that:

- (a) each affiliated club will only have access to, and the right to use, information collected by that club in respect of persons who are members of that club;
- (b) Level Assessors will only have access to, and the right to use information specifically related to the performance of their duties;
- (c) members will only have access to their personal information;
- (d) HRCav will have access to, and the right to use, all information contained in the Database however it is collected, including the right to access and use information collected by affiliated clubs.

It is acknowledged and agreed in relation to the Database that:

- (a) each club entitled to access the Database must nominate a club member, who will be provided access on behalf of that club and who must agree to terms and conditions relating to such access;
- (b) each club is authorised to enter information in the Database relevant to that club and to amend or delete that information entered by the club;
- (c) each Level Assessor granted access to the database must agree to the terms and conditions relating to such access and is authorised to enter details of assessments performed;
- (d) both HRCav and the Third Party Contractor are entitled to unlimited access and editing power in respect of the entire Database;
- (e) clubs are responsible for entering the relevant club information and relevant information of each club's registered members into the Database,
- (f) clubs may forward relevant information to the HRCav for entry into the Database. The HRCav reserves the right to charge an administrative fee for this service
- (g) HRCav may directly enter information of persons which is not captured by clubs including, but not limited to, officials, assessment details and competition results .
