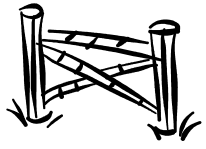

Conditions Of Entry:

1. The Event is being run according to HRCVA Rules & Regulations.
2. Competitors cannot jump higher than their assessed level.
3. Advanced and Level 1 will be combined if insufficient entries.
4. Competitors must supply their own number to be displayed on both sides of horse.
5. Riders must present for gear check 20 mins prior to competing. Medical armbands must be worn.
6. Valid Membership & SJ cards must be presented to Event Secretary prior to competing.
7. All refunds are subject to a \$10 administration fee.
8. There shall be no refunds after 30th November 2019 unless notified prior to ride time to ajmackie@people.net.au and a valid veterinary or doctor's medical certificate is provided within 14 days of the event.
9. The decision of the Ground Jury is final; no secondary protests will be entered into. Protests must be lodged within 30 minutes of the posting of interim results with a refundable fee of \$50.
10. The Organisers reserve the right to cancel any Class or Competition; to divide any Class; to alter the advertised times or to refuse entry with or without stating the reason.
11. SCRC Inc & SCRRR COM does not accept any liability for any accidents, damage, injury, illness or loss to any person, horse or property.
12. Dogs must be secured on leashes at all times or else elimination will occur.
