Minimum Performance Criteria for awarding points:

 $\ensuremath{\text{DRESSAGE}}$ - Placing competitors must attain a minimum of 60%

SHOWJUMPING – In competitions which have provision to separate equality for first place, competitors who fail to jump clear (faults or time) in the preliminary round/s will be ineligible for points.

HORSE TRIALS – Placing competitors who score 60 or more CC penalties are ineligible for performance points.
