



RULE CHANGES EFFECTIVE 1ST JULY 2022

SHOW JUMPING RULES

SJ rule 55.5 – before the table insert:

In all formulas, there must be a time allowed in both Phases, with a penalty for exceeding the time allowed of **1 penalty** per second or commenced fraction of a second.

SJ rule 38 – amend as follows: **1 penalty** for each second or commenced fraction of a second.

HT/CT RULES

Add new rule 27.3

A briefing of jump judges must occur prior to commencement of the cross country phase. The briefing is to take place with the technical delegate, medical personnel, course controller/central control and all (as far as practicable) jump judges. If required, the Organising Committee can run extra/additional briefings, particularly when cross country runs over more than one day.

The briefing must cover management of rider falls, horse falls, loose horses and the basics of cross country jump judging, being safety of fallen riders, crowd control, traffic control at fences and the recording of riders and faults. The briefing is to be arranged by the organising committee and must be conducted by a person experienced in running the cross country phase. This will generally be someone carrying out the role of course control/central control.

Section 7 Three-Phase Equitation PREAMBLE	Change the wording from "Official Navigation Ride Events" changed to state "Three-Phase Equitation"
Clause 1.3	Remove wording "Each Phase is to be awarded individually as per rule number 16"
Clause 12.2 (Level 4 Description)	Add - "The horse should be going forward willingly and calmly. Halts should be square in front"
15. TABLE OF PENALTIES - PHASE 2 STYLE	Elimination column – Remove "Resistance exceeding 15 seconds on course unrelated to obstacle*"
16. TABLE OF PENALTIES - PHASE 3 SPEED AND ACCURACY	Elimination column - Replace "Refusal/Resistance exceeding 15 seconds related to an obstacle*" to state "Third Refusal/Resistance* on course exceeding 15 seconds"
16. TABLE OF PENALTIES - PHASE 3 SPEED AND ACCURACY	Elimination column - Remove " Resistance exceeding 15 seconds on course unrelated to obstacle*"
16. TABLE OF PENALTIES - PHASE 3 SPEED AND ACCURACY	5 seconds each occasion column – Remove "Bridge, varied footing or timber bank: Trot or canter"
16. TABLE OF PENALTIES - PHASE 3 SPEED AND ACCURACY	ELIMINATION column – add "Bridge, varied footing or timber bank: Trot or canter"
Clause 19.2	Remove the clause number
Example Three Phase Equitation points scoring	Change to read "Example (refer to Clause 18) "Three Phase Equitation overall points scoring"
Example Three Phase Equitation points scoring	Table to be updated in line with updated Overall Scoresheet
1. Two Barrels	Add – "left or" right hand barrel "as per the course instructions" *Second sentence will read - Enter the obstacle, perform circle around the left or right hand barrel as per the course instructions, then circle around the left hand barrel.
2. Three Barrels	Add under first paragraph – "Obstacle can be ridden with first barrel to the left or right as per the course instructions"
2. Three Barrels	Add above second paragraph – "Example;"

5. Bridge (Bridge construction guidelines)	Add- "If side rails are use, for safety the rails must be constructed in such a way that they can be quickly and easily removed without the use of tools."
8. Jug ((Judging Criteria)	Replace "lift jug above head" with "lift jug above shoulder"
9. Side pass pole (Speed and Accuracy phase)	Replace "At Level 5 this obstacle is not permitted" with "Levels 5, 4 and 3, this obstacle is not permitted"
10. Bell Corridor	Add to last box of Judging Criteria table – "In level 5 the expectation is that transitions will be performed within 3 strides of the bell, in level 4 within 2 strides of the bell and in level 3 within 1 stride of the bell. By level 2 all transitions should be smooth and on the bell."
11. L Corridor rein back	Add to last box of Judging Criteria table – "All transitions should be smooth and with the rider in-line with the end of the corridor."
12. Switch Cup	Add to last box of Judging Criteria table – "In level 5 the expectation is that transitions will be performed within 3 strides of the cup, in level 4 within 2 strides of the cup and in level 3 within 1 stride of the cup. By level 2 all transitions should be smooth and on the cup."
19. Varied Footing	Amend to read – "The Varied Footing frame must be a min of 3 metres in length, 1 metre wide and no more than 20cms high. It must be constructed of planks/sleepers with edges rounded, no internal braces, boxes or sections and no sharp protrusions. The footing must be a non-slip material."

3 - TYPE OF 3PE EVENT	Under b) – Change wording from "concurrently" to "consecutively"
9 - COURSE PLAN APPROVAL	Add dot points regarding designing the course; <ul style="list-style-type: none"> • Consider the level of rider when designing the course (e.g. Level 5 have a simplified course) • Ensure the course flows and riders are able to meet the judging criteria • Includes instructions for obstacles such as the 2 or 3 Barrels, Side pass pole and Stock Pen.
11. TROPHIES AND PRIZES	Remove "such as Jackpots/Championships"
11. TROPHIES AND PRIZES	Add -"special" before award. First point to read "Order any trophies required including special awards"

13. PREPARING THE COMPETITION DRAW	Add - "Send final draw to Judge along with approved Course map"
2. CARDS	Add - "if a Card Free event, check member status before the event"
