5. Riders must supply their own bridle or saddle cloth numbers and be worn on both sides of the horse.
6. Registered club colors and approved helmets and riding boots must be worn, at all times.
7. Riders must present for gear check 20min prior to their allocated time
8. \$20 refundable fee for protests must be lodged no later than 30 mins after the interim scores posted.
9. The Ground Jury's decision is final, and no secondary protests will be entered.
10. The Colac & District ARC Inc. does not accept any liability for accident, injury, illness, damage or loss to any person, horse, or property.
11. The Committee reserves the right to cancel classes or otherwise amend the program. If classes are cancelled a full refund will be made.
12. If medical attention is deemed necessary, an ambulance will be called at the cost of the injured party.
