5. Competitors must enter at their assessed 3PE level
6. Riders must present to Gear Check 20 mins prior to Phases 1 & 2 fail to do so will be elimination.
7. Official HRCav September 2020 Dressage Tests and July 2024 Three Phase Equitation Rules
8. **Dogs must be on lead**
9. No smoking in food areas.
10. Protests must be submitted in writing to the Event Secretary with a \$20 deposit. The decision of the ground jury is final, and no secondary protests will be entered into.
