1. This event will be run under HRCVA Rules and Regulations – CARDLESS EVENT
2. No refund after the closing date unless vet or doctor's certificate is provided within 14 days.
3. Competitors must compete at their assessed 3PE Level
4. Riders must supply their own bridle or saddle cloth numbers and worn on both sides of the horse.
5. Registered club colors and approved helmets and riding boots must be worn, at all times.
6. Riders must present to gear check 20 mins prior to dressage and obstacle phase. Failure to do so will result in elimination.
7. \$20 refundable fee for protests must be lodged no later than 30 mins after the interim scores posted.
8. Ground Jury's decision is final, and no secondary protests will be entered into.
9. The Colac & District ARC Inc. does not accept any liability for accident, injury, illness, damage or loss to any person, horse, or property.
10. The Committee reserves the right to cancel classes or otherwise amend the program. If classes are cancelled a full refund will be made.
11. If medical attention is deemed necessary, an ambulance will be called at the cost of the injured party.
