CONDITIONS OF ENTRY

- This event is a **CARDLESS EVENT** and will run in accordance with HRCVA Rules. Only HRCVA members can enter
- Riders are to supply their own numbers (breastplate, saddle pad or bridle), displayed on both sides of the horse
- All competitors must wear approved helmets, boots and club uniforms
- Reservation Of Right As Per Event Rule 15.1
- All riders must present for a gear check 15 minutes prior to their allocated time in Phase 1 and 2
- Competitors on foot will be permitted access to the obstacle course during applicable level course walk
- No refunds after the closing date unless a doctor or veterinary certificate is supplied within 14 days. All refunds will incur a \$15 administration fee
- Protests must be lodged within 30 minutes of the posting of interim results accompanied by a \$20 deposit. The Ground Jury decision is final: no secondary protests will be entered into
- Riders may be required to assist with a duty (canteen, scribe, ground steward etc.) during the day
- Dogs must be secured on a leash at all times and cleaned up after. If dogs are causing a nuisance to riders/horses, they and their owners will be asked to leave the premises
- YRC accepts no liability for accidents, damage, injury, illness or loss to horses, people, or property
