CONDITIONS OF ENTRY:

- Event to be run under HRCV rules and regulations. This is a cardless event as per HRCV rules.
- Entrants must ensure they meet qualification requirements as per Event Rule 39.7.
- Membership, Level Assessment and TTT Qualifications will be checked prior to the draw being completed. You **MUST** have any level assessment or verification completed or TTT log submitted (to Office@eventsecretary.com.au) prior to close of entries.
- All Teams must supply a volunteer/s for approximately 4 hours. Failure of a volunteer helper/s to report for duty may result in elimination of the team.
- Refunds are subject to a \$20 administration fee. There shall be no refunds after close of entries (30th September) unless Event Secretary is notified prior to your first ride time and a valid veterinary or medical certificate is provided with 14 days of scratching.
- The organising committee, YHEC, HRCV, and WPNEC, accept no liability for accidents/injury/illness/loss to any person/animal/property.
- Body protectors are compulsory for the cross country phase and must be in line with CT & HT rule 2.2.1

- Competitors to supply their own number holders. Numbers are to be displayed on both sides of the horse for all phases. During the Cross-country phase, riders must also wear numbers on their front and on their back.
- Registered Club colours; tagged riding helmets and approved boots must be worn. Logo must be visible on either the saddle blanket or rider.
- Riders must present for gear check 20 mins prior to each phase.
- Protests, including scoring queries, must be lodged within 30 minutes of posting of results and must be accompanied by a refundable \$50 deposit. Disputes regarding team placings must be accompanied by a non-refundable fee of \$50.
- The decision of the Ground Jury is final; no secondary protests will be entered into.
- RESERVATION OF RIGHTS AS PER Event Rule 15.1.
- Prizes must be collected during the event. Sashes will be mailed if address and \$2 postage fee is given on the day.
- Dogs to be on a leash at all times. No dogs on XC course whilst cross-country is in progress.
- Random swabbing of horses may occur.
