CONDITIONS OF ENTRY:

1. This competition is open to Riding Clubs affiliated with HRCav and will run under HRCav rules and regulations.
2. Competitors must ride at their assessed HRCav level and may ride one level higher pending availability.
3. Competitors to provide their own bridle/saddlecloth numbers. Numbers are to be worn on both sides of the horse.
4. Competitors must present to gear check 20 minutes prior to their first dressage test and be wearing approved riding helmets and riding boots.
5. Protests must be launched within 30 minutes of protesting interim scores and must be accompanied by \$20.00.
6. No secondary protest may be entered. The decision of the ground jury is final.
7. **This event is a card free event -membership and level assessment will be validated prior to the event; you will need not to present your cards before you, but you must have them with you.**
8. No refunds will be issued unless a valid veterinary or doctor's certificate is provided within 14 days of the completion of the event. A \$10 administration fee will be deducted from all refunds.
9. RRC accepts no responsibility for injury, damage to any competitor/spectator/horse/ equipment/property.
10. HRCav extreme weather policy and horse welfare shall be observed. Should weather conditions be unsuitable for running a safe event, the committee reserve the right to postpone or cancel. Please note that in such circumstances, an administration fee of \$10 per entry will be withheld to help recover incurred costs.
11. Reservation Of Right as per Event Rule 15.1
12. Competitors are expected to pick up their horse's manure and dispose of it in their prescribed manure area.
13. **Dogs must always be on a leash and not disruptive to other competitors or else elimination will occur and you will be asked to leave.**
14. Competitors must be assessed to enter the walk/trot tests
